Course Description

This two-day, in-person workshop advances evidence-based infant feeding policies and practices in the hospital or clinic. It also provides the education cornerstone for hospitals who wish to pursue the designation of “[Baby-Friendly](#)” or “[Breastfeeding Friendly Washington](#).” This workshop explores the rapidly changing role of all healthcare professionals in caring for pregnant and new families and is designed to help hospitals, WIC staff and communities provide the basics of early breastfeeding care, with a focus on implementing the Ten Steps to Successful Breastfeeding.
